1. Purpose of the document

8. Data transfers outside the EU

9. Duration of data storage

Personal data is stored:

- 5 years documents related to audits and training;
- 10 years financial-accounting documents;
- 75 years employment contracts and personnel files;
- permanently diplomas, graduation certificates, certificates of conformity issued.

The duration may vary depending on the applicable legal requirements or the justified legitimate interest.

10. Rights of data subjects

According to the GDPR, data subjects benefit from the following rights:

- Right of access to data;
- Right to rectification;
- Right to erasure of data ("right to be forgotten");
- Right to restrict processing;
- Right to object;
- Right to data portability;
- Right to withdraw consent at any time;
- Right to lodge a complaint with the supervisory authority.
