- 2. You may accept all cookies or choose only strictly necessary ones.
- 3. You can change your settings at any time:

## 4. How to disable cookies

- **Chrome**: Settings → Privacy and Security → Cookies and other site data → See all cookies and site data → Delete/Block.
  - **Firefox**: Options → Privacy & Security → Cookies and Site Data → Manage Data.
  - **Edge**: Settings → Cookies and site permissions → Manage and delete cookies.

Please note that disabling functional or performance cookies may affect certain features of the Website.

## 5. Retention period

- Session cookies: deleted when you close your browser.
- **Persistent cookies**: stored on your device for a limited period (maximum 12 months), in accordance with legal requirements and internal policy.
